The applicable Close Price was Rs.1,682.00 (NSE) on Thursday, September 27, 2018.



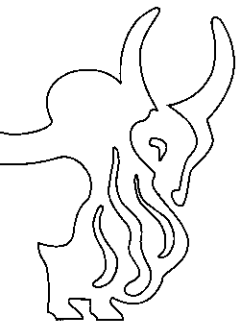
