**Sub: Grant of Options to employees of the Bank under the Employee Stock Option Scheme**

Pursuant to Regulation 30 of the SEBI Listing Regulations, 2015, we hereby inform that the Bank has, on August 23, 2016, granted 2,76,000 Options to 4 new joinees, representing 2,76,000 shares of Face Value of Rs. 10 each at the Close Price of Rs. 1,186.75 in NSE on August 22, 2016.

The grant of Options is in accordance with the Securities and Exchange Board of India (Share Based Employee Benefits) Regulations, 2014 and the ESOP Scheme 2007 of the Bank.


